**Directions for Circulating  
Greg Buck's Candidate Petition**

1. You must be a United States citizen and be at least 18 years of age, or you will be 18 by the date of the upcoming General Election. You need not have voted in a previous Republican Primary and may even have voted in a Democratic Primary or not ever voted in an election at all. The circulator can be from outside the district, county or state.
  2. You must personally witness all signatures made on this petition.
  3. You may sign your own petition.
  4. You may circulate this petition anywhere within Kane County Board District 23 (See attached map).
  5. You may not circulate petitions for more than one political party.
  6. Petitions with fewer than 10 signature DO count. If you are not able to fill a petition, send or give to me the partially completed petition. Each name is important.
  7. If you learn a signature is not valid, do not worry. Bad signatures do not knock out other good signatures or invalidate a petition. HOWEVER, known bad signatures should be brought to the attention of the campaign, so that they can be officially deleted. A circulator who recklessly and routinely disregards the signature gathering rules may have an entire sheet stricken even though some signatures are valid.
  8. You must complete the circulator's statement at the bottom of the petition sheet before a Notary Public and the Notary Public must affix his/her seal or stamp. Most banks will notarize free of charge.
  9. DO NOT number the petition page.

**Directions for Signing  
Greg Buck's Candidate Petition**

1. You must be a registered voter in the Kane County Board District 23. You need not to have voted in a previous Republican Primary and may have even voted in a Democratic Primary or not have voted in a primary or election at all.
2. You must sign your name as you are registered to vote. (i.e. William E. Jones, not Bill Jones)
3. DO NOT use ditto marks for any part of an address or county.
4. You must use the address where you are registered to vote. Post Office boxes are not acceptable.
5. You MAY NOT sign petitions for candidates of more than one political party in the same election cycle.
6. You cannot sign the petition for another person, even a member of your family.
